
New Bachelor Degree Education Programme Offered by KNEU: Digital Accounting

OBJECTIVE



Kyiv National Economic University offers, for the first time in Ukraine, bachelor degree specialised training *Digital Accounting* as part of Specialism 071: *Accounting and Taxes* for Academic Year 2018/2019.

Training objective: To train highly skilled accounting and tax professionals, strengthening the traditional professional accounting and auditing competencies and giving additional opportunity to make use of cutting edge theoretical knowledge and practical skills in the digital economy environment: knowledge of electronic business and IT law; accounting and auditing skills based on digital technologies and cloud infrastructures; intelligent business data analytics and monitored accounting environment programming skills; knowledge of cyber-security basics; ability to create and maintain diverse information resources.

DIFFERENCES FROM THE BASIC PROGRAMME



>The curriculum includes some new courses:

Programming of accounting ant tax systems;

Integrated information systems in accounting and tax management;

Digital auditing;

Entity reporting in the digital economy environment;

Digital economy;

Intelligent data analytics in accounting and auditing; and some others.

➤ Advanced practical programming skills and work with application packages of certain ERP systems (IT-Enterprise; Master: Accounting; SaaS Accounting; You Control; Case Ware; etc.).

ADVANTAGES FOR PROGRAMME GRADUATES

- » Certification as applied package solution users in the university after hands-on training by the application developers;
- » Ensuring synergism of diverse competencies and skills (programmer, accountant, analyst and auditor skills mastered by one professional);
- » High competitiveness at the labour market and high demand for digital accounting and auditing professionals;
- » (In addition to traditional positions), these graduates can be employed in the **new positions** of a digital manager, digital analyst, accountantprogrammer, network accountant, auditor of IT systems (digital auditor), etc.


ACHIEVEMENTS IN DELIVERING DIGITAL ACCOUNTING EDUCATION

- » Methodology and information support materials are being produced for these new courses;
- » Three up-to-date IT laboratories opened in 2018 (as innovation centres for automated accounting and auditing) with cutting edge hardware and software;
- » Cooperation agreements concluded with software development companies and hands-on trainers involved in the teaching process;
- » Interest demonstrated by some other Ukrainian universities to study the experience gained by KNEU.
