### CONTEXT

Over the last few years investors, companies, governmental regulators, international organizations have been increasingly calling for standardization of sustainability/integrated reporting by corporations and, in the longer term, by governments. They also see an urgent need to consolidate a wide range of organizations and initiatives currently involved in this agenda. The ongoing COVID-19 pandemic and focus on the sustainable recovery have helped to further cement this momentum.

On September 30, 2020 the IFRS Foundation, which acts as a global guardian overseeing standard setting process for corporate financial reporting and is responsible for development and promotion of the International Financial Reporting Standards, launched public consultations seeking to assess whether the Foundation should add sustainability reporting to its core mandate.

The key objectives of this SIT are: (i) explore trends driving evolution of the global sustainability standards; (ii) understand how development and implementation of sustainability reporting could affect global private and public markets and financial flows; (iii) analyze opportunities and challenges of sustainability reporting for public sector accounting.

The event will be simultaneously translated into Albanian, Croatian/Bosnian/Serbian, Russian, and Spanish.

#### **DMITRI GOURFINKEL**

Senior Financial Management Specialist, PULSAR FINCOP Team Leader, World Bank

compliance in a number of countries. From 2004 to 2009, he worked as Chief Accountant at the Australian Securities and Investments Commission (ASIC), where he provided oversight and supported Australian companies in their transition to IFRS Standards. He was also a member of the Australian Financial Reporting Council and the Australian member of both the International Organization of Securities Commissions and the International Forum of Independent Audit Regulators. Prior to joining ASIC, he served as Assistant Auditor-General at the Audit Office of New South Wales from 1994 to 2004 and as an Audit Principal with PwC (then Coopers & Lybrand) from 1984 to 1994. Mr White has a Bachelor's degree from Macquarie University in Sydney, Australia. He has been a Fellow of ICAA since 1998.

Ian is the current Chair of the Corporate Reporting Dialogue. He was formally Vice-Chairman of IASB. He is a former Chief Accountant of the Australian Securities and Investment Commission (ASIC) and has more than 30 years' experience of national and international accounting standard-setting. He is a former chairman of the UK Accounting

Standards Board (a precursor to the FRC) and has substantial public sector experience, having chaired both the Australian Public Sector Accounting Standards Board and the IFAC Public Sector Committee.



#### **TATIANA KRYLOVA**

Head of Enterprise Branch, Division on Investment and Enterprise Development, UNCTAD

Tatiana Krylova is the Head of Enterprise Branch, Division on Investment and Enterprise Development of the United Nations Conference on Trade and Development (UNCTAD). Her duties, among others, include supervision and coordination of activities of the United Nations

Intergovernmental Working Group on International Accounting and Reporting Standards (ISAR) to assist developing countries and economies in transition to meet international requirements in the area of accounting and reporting. Before joining the United Nations in 2000, she was a partner at KPMG in Moscow where she was in charge of the Methodology department that advised Russian government and companies on transition to IAS/IFRS. She was also a consultant to the World Bank, OECD, EBRD, and other international organizations on accounting and finance issues. In different years she was a member of the Standards Advisory Council of the IASB, of the Education Committee and the Developing Nations Committee of the International Federation of Accountants. She holds a PhD degree in accounting from Moscow State University and was a Visiting Fellow at Stanford University, California, in 1992-1993.



#### **FIONA STEWART**

Lead Financial Sector Specialist, Finance, Competitiveness & Innovation, World Bank

Fiona Stewart works for the World Bank's Global Capital Markets, Nonbank Financial Institutions group, which provides policy advice on pension reform to governments around the world. Previously, she worked for the OECD's Financial Affairs Division for eight years and led

the Secretariat of the International Organisation of Pension Supervisors (IOPS), an international body representing over 70 countries, dedicated to cooperation and research on pension supervisory issues. Prior to working at the OECD, Fiona worked in the pension fund industry. As head of American Express Asset Management in Japan she was responsible for investing \$2bn in Asian equity markets, and, as part of an international team, for managing \$20bn globally. She holds degrees from Oxford and Johns Hopkins Universities and a Chartered Financial Analyst qualification. She also served on the advisory board of one of the OECD's own pension funds.



#### IAN CARRUTHERS

IPSASB Chair, Chair CIPFA Standards

Ian Carruthers became Chair of the International Public Sector Accounting Standards Board (IPSASB) in 2016, having been a Board Member since 2010. As a Board Member he led IPSASB's work on Long Term Financial Sustainability and alignment between IPSASs and Government Finance Statistics. IPSAS issued during Ian's chairmanship

so far include those on Social Benefits and Financial Instruments. Currently in his second term (2019 – 2021), Ian has now been reappointed as IPSASB Chair for a third term through to the end of 2024. After joining HM Treasury from PricewaterhouseCoopers in 1999, Ian played a key role in the UK Government's transition from cash to accrual budgeting and reporting, in particular leading its Whole of Government Accounts programme. He joined CIPFA in 2006. As part-time Chair, CIPFA Standards, Ian has been involved in all these aspects of the Institute's activities, including leading its work on the Role of the Public Services CFO, and the development of the International Framework for Good Governance in the Public Sector in partnership with IFAC.
