The Public Oversight Board (BMP) in cooperation with the Austrian Audit Oversight Authority - APAB, has organized a two-day training by quality assurance inspectors from APAB at offices of the Public Oversight Board, on March 23 - 24, 2023, in Tirana, Albania. This activity is being implemented as part of the package "Strengthening oversight and enforcement TA for POB and improving of professional qualification and examination process for accountancy profession", by providing an insight of the inspection practice of the Austrian Audit Oversight Authority – APAB regarding the stages of the inspection process, the risk analysis of the statutory auditor/audit firm and the risk analysis for the selection for inspection of the engagement file, the methodology of performing quality control, the computerized program for performing PENTANA inspections, as well as other issues related to the strengthening of capacities that serve the growth and quality of the practice of the profession.
