FOREWORD

The PULSAR Program, launched in 2017, is a regional and country-level program for 13 beneficiary countries in Europe and Central Asia. Its objective is to support the enhancement of public sector accounting (PSA) and financial reporting frameworks, in line with international standards and in accordance with good practices, to improve government accountability, transparency, and performance.

The objectives and scope of the PULSAR Program are jointly determined by the PULSAR Partners – Austria, Switzerland, and the World Bank – who also provide institutional support for its implementation and mobilize the resources needed for its activities. Beneficiary countries help shape the PULSAR Program through regional cooperation platforms and inputs to the two Communities of Practice (CoP): the Financial Reporting (FinCoP) and Education Communities of Practice (EduCoP).

Consolidation is one of the essential and, at the same time, challenging processes in terms of implementation of PSA reforms. IPSAS 35 "Consolidated Financial Statements" provides specific guidance on consolidation, which uses an economic perspective that is based on the concept of control. However, the consolidation in public sector possess is particularly challenging given its complex organization and wide range of decentralized and subnational entities, including State-Owned Enterprises (SOEs), which, often use different accounting framework.

Some of the most critical challenges are the automation of consolidation process and development of proper mechanism for elimination of inter-institutional transactions to ensure the reporting of only economic activities with external parties rather than including internal transfers among different governmental agencies.

In order to properly tackle these challenges, the use of Integrated Financial Management Information Systems (IFMIS) and its interfaces between different types of public sector entities, becomes essential to ensure that the financial information prepared by the governments is reliable, relevant, and useful for decision making process.

On the other hand, the role of sustainability reporting in private and financial sectors is increasing, and development of the first sustainability reporting related standards for the public sector is eminent. In this context, the government officials need to become aware and start getting ready for implementation of sustainability reporting practices in their respective countries.

The main objectives of this face-to-face workshop will be focusing on:

- Discuss the IFMIS implementation process and the relevance of integration between budget, financial accounting/reporting, and fiscal statistics.
- Discuss the process of the consolidation of financial statements prepared under different reporting frameworks, including local governments and State-Owned Enterprises (SOEs), and the role of the IFMIS.
- Discuss the latest developments in sustainability reporting and its implications for public sector in terms of legislation, organizational arrangements and roles, link with financial reporting, practical aspects, such as disclosures, and capacity building.

As a Board Member he led IPSASB's work on Long Term Financial Sustainability and alignment between IPSASs and Government Finance Statistics. IPSAS issued during lan's chairmanship so far include those on

Social Benefits and Financial Instruments. Currently in his second term (2019 – 2021), Ian has now been reappointed as IPSASB Chair for a third term through to the end of 2024. After joining HM Treasury from PricewaterhouseCoopers in 1999, Ian played a key role in the UK Government's transition from cash to accrual budgeting and reporting, in particular leading its Whole of Government Accounts programme. He joined CIPFA in 2006. As part-time Chair, CIPFA Standards, Ian has been involved in all these aspects of the Institute's activities, including leading its work on the Role of the Public Services CFO, and the development of the International Framework for Good Governance in the Public Sector in partnership with IFAC.

the board as a public member since 2006. He is a member of the Swiss Accounting Standard Setter

for the Public Sector (SRS-CSPCP) since 2009, and a member of the European Commission Accounting Advisory Group since 2010, both ongoing. In 2010, Mr. Bergmann was a Visiting Professor at Victoria University in Wellington, New Zealand. He is a scientific advisor on PFM reforms in Switzerland, Europe, Central Asia, Latin America, South East Asia, and to various international organizations. From 2003 to 2009, he was the Scientific Advisor for the public sector accounting reforms at the federal and state level in Switzerland. He was also a member and later Chair of the advisory committee for GFSM2001/ESA95 implementation in Switzerland. In 1999, he joined Zurich University of Applied Sciences as a Senior Lecturer and became a Full Professor in 2002. Mr. Bergmann started his career as a business consultant before joining the Ministry of Education of the State of Zurich as a Project Manager for NPM Reforms/Head of Controlling.
