


Key Messages

- » Report on the Observance of Standards and Codes Accounting and Auditing:
 - » Fully integrated in REPARIS for SMEs and EASSURE
 - » Benchmark assessment used across 121 countries
 - » Built around 3 modules and seven indicators
 - » Necessitate a request and full cooperation from country authorities

ROSC A&A

- » After the Asian crisis of the late 1990s the G7 and Financial Stability Forum requested the IMF and the World Bank to monitor 12 standards and codes including IFRS and ISA and risks that increase the likelihood or potential severity of financial sector crises.
- » 168 ROSC A&A in 121 countries across the 6 WB regions
- » 160 ROSC A&A published
- » 90 Technical assistance follow up projects
- » The ROSC A&A is an benchmark assessment for financial reporting and auditing performed by the World Bank using IFRS and ISA who review:
 - » The soundness of the system versus its vulnerabilities
 - » The developmental needs in terms of infrastructure, institutions and markets
 - » The compliance with the accounting and auditing through IFRS and ISA.





ROSC A&A - 3 Modules with 11 sub-modules

- » 2 core benchmarks: IFRS & ISA
- » A regional benchmark EU Acquis
- » 9 technical topics on FR and Auditing
- » 3 desk reviews complemented by interviews.


