FOREWORD

The Ninth International Symposium of Accountants and Auditors takes place at a time of geopolitical tensions caused by the war in Ukraine, global climate challenges, political uncertainty, and technological progress bringing artificial intelligence that will have a great impact on the usual business and life patterns. The challenges of adapting to the new conditions affect all parts of political, social, and economic life, including the accounting and auditing profession.

In the new, complex, and very dynamic conditions of business, the accounting/auditing profession must be adaptable and able to respond to different needs, above all the preservation of the public interest, along with the sustainability of the profession itself and clients. The **Institute of Certified Accountants of Montenegro (ICAM)** has been successfully cooperating for many years with our national, regional, and international partners, including the International Federation of Accountants (IFAC), the European Federation of Accountants (Accountancy Europe), the World Bank Group, regional associations of professional accountants, the Faculty of Economics in Podgorica, and many others. Their experience and knowledge are of great importance to us in terms of support and assistance. We also appreciate the support of Montenegrin legislative institutions and regulators with whom ICAM has a long-term cooperation and partnership relationship.

Economic shocks in the last two years, due to non-economic factors, require a competent and energetic reaction in Montenegro, the surrounding economies, and beyond. The Montenegrin economy faces rising prices, growing unemployment, and increased public debt with a drop in credit rating and decreased liquidity of the economy. The accounting and auditing profession in Montenegro is key to maintaining the quality of financial reporting. The profession successfully responded to the financial scandals at the beginning of this century that revealed numerous cracks in the regulatory framework. Facing deeper, even more difficult, and therefore more serious problems, today the profession must provide quality responses to threatening economic fluctuations.

The application of new international standards of financial reporting is a special challenge for accounting professionals. Montenegro's desire to join the EU as soon as possible necessitates the transposition of EU regulations in the field of accounting and auditing into national legislation. While significant progress has been made in this work, regulations and standards

alone are not enough. Establishing the rule of law, strengthening the national association, and improving accounting practice are just as important as good legislation. Respect for ethical principles and codes is imperative in the actions of all actors of the accounting profession. Ultimately, this is a crucial determinant for the development of the profession and an inevitable step in achieving a socially efficient outcome, that is, in the public interest.

It is our great pleasure to hold this year's Symposium in cooperation with the World Bank Centre for Financial Reporting Reform (CFRR). The second day of the Symposium will take the form of a National Conference covering two key areas such as sustainability reporting and the role of audit committees, delivered in cooperation with the CFRR, involving ICAM and its local and international partners.

FOREWORD

The Road to Europe Program of Accounting Reform and Institutional Strengthening for Small and Medium Enterprises (<u>REPARIS for SMEs</u>) aims to support: (i) further improving access of SMEs in the Western Balkans to professional accounting and financial management services, and (ii) alignment of Western Balkans corporate financial reporting frameworks with relevant directives and regulations of the European Union (EU). Program beneficiaries are Albania, Bosnia and Herzegovina, Kosovo, Montenegro, North Macedonia, and Serbia.

REPARIS for SMEs builds on progress made under the completed EU-REPARIS Program (2015-2019). It is delivered by the **World Bank Centre for Financial Reporting Reform** (CFRR) based in Vienna, Austria in close cooperation with World Bank Country Offices in the beneficiary countries. Program activities include training, learning events, and technical assistance provided to public officials, regulators, accountants, auditors, professional accounting organizations, business support organizations, and chambers of commerce. The main components of the program are:

- (A) Supporting the development and implementation of sustainable education and training programs.
- (B) Support for the transposition and alignment of national legal frameworks and practices in financial reporting and auditing with the EU requirements.
- (C) Encouraging a regional approach to the implementation of completed accounting and audit reforms.
- (D) Landscape assessments of accounting advisory services and the Accounting and Auditing Reports on the Observance of Standards and Codes (A&A ROSCs).

This Conference aims to raise awareness of the corporate sustainability reporting framework and discuss how to strengthen corporate governance, with a particular emphasis on stateowned enterprises (SOEs). It will highlight the role of audit committees in both financial and sustainability reporting. The event seeks to encourage discussions and sharing of good practice on these topics by bringing together various groups of relevant stakeholders – board members, including members of audit committees, auditors, certified accountants, academics, and representatives of state regulators and competent authorities in the field of accounting, auditing, public oversight, banking, and insurance.

The Conference will discuss challenges and potential responses related to: (i) new provisions of the EU Corporate Sustainability Reporting Directive (CSRD),¹ including new European Sustainability Reporting Standards (ESRS);² (ii) adoption of the EU sustainability reporting requirements into local legislation; and (iii) the increasing role of audit committees in strengthening confidence in statutory audit and in financial and non-financial information especially in SOEs.

Expanding the scope of sustainability reporting matters, the CSRD requires all large and listed EU companies (with an opt-out for listed SMEs until 2028) to introduce mandatory sustainability reporting standards. Entities will need to report in line with the new ESRS developed by the European Financial Reporting and Advisory Group (EFRAG) and adopted by the European Commission on July 31, 2023. External assurance on the sustainability information provided is required. Given the substantial regulatory change triggered by the CSRD, it is important that the profession and companies begin preparing for it as soon as possible. The conference will raise awareness of the aims and requirements of the CSRD and ESRS and consider what actions are needed in Montenegro.

The focus on audit committees reflects their enhanced role in strengthening confidence in the statutory audit and in financial information. The audit committee is increasingly a key factor within the corporate governance framework, including both financial and sustainability reporting. Discussions will include SOEs, given their significant role in the economy of Montenegro. There are 51 state-level owned enterprises and about 100 municipality owned local enterprises. SOEs in Montenegro follow the same financial reporting obligations as other companies and have minimum publication requirements according to their size.

The language of the Conference is English with simultaneous interpretation into Montenegrin.

New European Sustainability Reporting Requirements

Sustainability, and in particular climate, is a defining issue of our time. The overall objective is to reorient capital flows towards sustainable investment to achieve sustainable and inclusive growth; manage financial risks stemming from climate change, resource depletion, environmental degradation, and social issues; and foster transparency and long-termism in financial and economic activity. The CSRD requires all large companies and all companies listed in the EU to disclose their business strategy on sustainability, sustainability targets they have set, and progress made towards them. The presentation will provide a general overview of the content of the ESRS and existing implementation guidance and will outline key CSRD provisions.

VINKO NIKIĆ

President of the Board, Institute of Certified Accountants of Montenegro

Mr. Vinko Nikić, PhD, is the President of the Board of the Institute of Certified Accountants of Montenegro since 2012 and was previously the Vice President of the Board for four years. Mr. Nikić is Group CEO of the Aqua Mont Group for Serbia, Croatia, Romania and Montenegro

since July 2023. Since 2024, he is the President of the Board of Directors of micro-finance institution "Win Credit". From 2014-2023 he worked in Lovcen Bank as Executive Director, CEO, and President of the Board of Directors. From 2012 -2014 he worked as a Manager in PwC, Montenegro, where he was involved in developing PwC business activities in Montenegro. From 1999 to 2012, Mr. Nikić held several managerial positions in Jugopetrol AD Kotor (Hellenic Petroleum Group) as Head of Accountants, Head of Finance, and CFO. He worked earlier in Transped Belgrade – Branch Office for Montenegro and prior to that in Montenegrotourist, Budva, Montenegro. His areas of expertise are finance and accounting, managing of projects, business plan preparation, corporate finance, finance consulting, value appraising, and market analysis. Mr. Nikić has been a professor at Adriatic University for more than 15 years. Mr. Nikić holds a License of Auditor; Certificate and License for Certified Accountant of ICAM Montenegro, Certificate and License for Certified Public Accountant of AAA Serbia, and Certificate of Authorized Appraisers of Montenegro. He is also a Vice President of the Association of Montenegrin Managers.



ASMAA RESMOUKI

President, International Federation of Accountants

Ms. Asmaa Resmouki has more than thirty years of experience in the profession, including serving as audit partner in the large auditing firms Deloitte and EY in Morocco. In 2020, she started a consultancy practice firm assisting different organizations in projects relating to the profession and to advisory services. Ms. Resmouki became IFAC

President in November 2022. She was previously Deputy President since November 2020. She joined the IFAC board in November 2017, originally nominated to the board by the Ordre Des Experts Comptables—Morocco. As Deputy President, Ms. Resmouki chaired the IFAC Planning

and Finance Committee, and earlier chaired the board's Governance Subcommittee prior to her election as Deputy President. Ms. Resmouki is a Past President of the Pan African Federation of Accountants (PAFA). She served on the PAFA Board since 2011, as vice president and chair of the Planning, Human Capital, and Financial Committee from 2013 to 2015 and as president from 2015 to 2017. She served in voluntary roles in the Moroccan accounting profession from 2008 to 2014, especially in quality control field. Thanks to her diverse and wide experience, Ms. Resmouki has developed as a thought leader in the development and strengthening of the accountancy/auditing profession, as well as an expert in good corporate governance and best practices to manage and lead robust boards and committees.



MILAN DABOVIĆ

Senator of the State Audit Institution of Montenegro

Prof. Milan Dabović, PhD, is the Senator of the State Audit Institution of Montenegro. He was appointed as a member of the Senate of the State Audit Institution for managing the public sector audit in 2006 and was appointed as President of the Senate in August 2013. Previously he served as a scientific advisor at the Institute of Economics in

Belgrade from 2008, and was the General Director for Budget at the Ministry of Finance of Montenegro from 1998 to 2006. He graduated from the Faculty of Economics in Podgorica. His doctoral dissertation was entitled "Structural disproportions in the Yugoslav economy and possibility of overcoming them". Prof. Dabović's pedagogical activities include lecturer and member of the Exam Commission of the Faculty of Law, University of Belgrade; lecturer and member of the Exam Commission of the State Audit Institution of Montenegro; lecturer and member of the Exam Commission of the State Audit Institution of the Republic of Serbia; associate professor at the University "Mediteran" Podgorica; honorary title of professor at Nanjing University of Auditing; lecturer at the University of Donja Gorica, Faculty of Law on "Financial Law" in 2022.



RATKO NIKOLIĆ

Executive Director of BI Consulting

Mr. Ratko Nikolić is Executive Director of Business Intelligence Consulting (BI Consulting). He began his career in domestic and foreign commercial banks in Montenegro, first at Nikšićka, and then at Euromarket, Hypo Alpe Adria, and Erste Bank. He then founded BI Consulting, and in 2014 created the first business information portal in Montenegro, Blnfo.me, through which registered users have access to daily up-to-date and objective information about all Montenegrin companies, collected from a significant number of public and private sources, analysis of their financial situation, assessment of the risk level of doing business with them, etc. Service from the very beginning has become an indispensable tool in all commercial banks, domestic and international financial institutions that are present in Montenegro, as well as the most important Montenegrin companies that actively manage business risks. In addition, he is one of the founders and the main analyst in the initiatives that promote successful and orderly operations, the culture of financial reporting and business ethics: 100 largest in Montenegro (from 2017 to 2022), Top Woman Business Montenegro (from 2022) and Top Business Montenegro (from 2023). He graduated from the Faculty of Economics in Podgorica in 1998.



SILVIJE ORSAG

Faculty of Economics, University of Zagreb, Croatia

Prof. Silvije Orsag, PhD, is a full professor at the Faculty of Economics, University of Zagreb, where he teaches financial management of companies and financial management of business combinations. He is co-leader of the PDS finance of companies and course leader in external and internal financial analysis. He is head of the course

management of company finances at all PDS of the Faculty of Economics. He also taught at PDS in Rijeka and Osijek, and is the head of the finance course at DSM FER. He is a member of the European Federation of Financial Analysts Societies (EFFAS), the Western Decision Sciences Institute (WDSI) and Who is Who in the World. He is widely published in books, symposium papers, definitions in dictionaries, articles, and reviews, including in the magazines RIF, Economic Analyst, Banka, Ekonomija, Acta turistica, Prizma and Poduzetništvo.

Mr. Zoran Škobić has served as Director, Education and International Affairs, Serbian Association of Accountants and Auditors, since 2004. Prior to this, he was the Executive Director of the South-East European Program for Accountancy Development (2003–2004), Auditor at

in Montenegro and Bosnia and Herzegovina, Certified Fraud Examiner (ACFE) as well as member of several professional accountancy bodies, including the Public Interest Oversight Board of Republic Serbia, the International Federation of Accountants (IFAC), and Accountancy Europe.

Prof. Andjelko Lojpur, PhD, holds the title of full professor in the disciplines of Management, Basics of Management, Organizational Development, and Organizational Transformation at the Faculty of Economics in Podgorica; Management Theories at the Faculty of Maritime Affairs in Kotor; Leadership at the Faculty of Tourism and

Hospitality in Kotor, etc. As a manager and associate, he has participated in several projects including: Business plan of JP Port of Kotor in 2003, Report on the valuation of real estate, plant and equipment in accordance with "IAS 16", HTP "Miločer" doo Budva, Report on the integrity assessment "Izbor" AD Bar, Cetinje, October 2018. He is the author or co-author of publications (textbooks and manuals) including: "Corporate management in the theory and practice of privatization," "Contemporary issues in accounting and management research and education," "Sustainable development: Crisis or Regulation?"
